Highest Score at 80 yards (Hereford Round) – Recurve

Highest Score by a Novice Archer – Recurve (first year of shooting)

Worst White – Recurve/Compound/Longbow/Barebow

Best Gold at 100/80 yards – Recurve/Compound/Longbow/Barebow

Best Red at 1st end – Recurve/Compound/Longbow/Barebow

Longbow Archers: 1st – Trophy and Medal (Others according to entry)

Compound and Barebow Archers: 1st, 2nd, and 3rd – According to entry.

TEAM AWARDS

Gents Recurve Team – 4 highest scores from one club (York rounds)

Ladies Recurve Team – 3 highest scores from one club (Hereford rounds)

Compound/Barebow/Longbow teams – 3 scores from one club (York/Hereford rounds) – according to entry

VISITORS – Ladies and Gentlemen

1st, 2nd and 3rd highest scores – Recurve/Compound/Longbow/Barebow

PLEASE NOTE

1. We will be asking all archers to show proof of a valid AGB membership at the tournament – please bring your card (electronic or physical)
2. The tournament will be conducted according to AGB Rules, Dress Regulations 307 will apply.
3. Shooting will be under AGB Rule 304. Paragraph (f) Method 2. (i.e. 6 arrow ends in 4 minutes)
4. Target lists/results will be sent out the week before the tournament. Target lists and results will be available on lanseo.
5. Whilst all that is practical will be done, the organisers cannot be held responsible for damage to carbon arrows passing through bosses.
6. All rounds to be shot that are eligible for record status will be NATIONAL RECORD STATUS, and so competitors will be liable for drug testing. Competitors approached to give samples must comply.
If they refuse, that refusal will be treated as a positive result. Juniors must ensure that a parent guardian signs their entry form giving consent to a drug test if requested.
7. Under the provisions within the AGB Protection of Children and Vulnerable Adults Policy, those who wish to take photographs at this event are to register with tournament Organiser on arrival. Whilst every effort will be made to ensure that unauthorised photography does not take place, AGB, the Tournament Organiser working party cannot be held responsible for breaches of this code.
8. Any archer with a chronic medical condition is asked to notify the Tournament Organiser (in complete confidence) so that appropriate action can be taken in the event of recurrence.
9. GDPR – By entering this event you agree that the details given on the entry form may be published in documents or lists relating to the tournament, or for any archery award claims made at the shoot.
